



## **GOLF CART/ATV/UTV RULES & REGULATIONS**

### **ALWAYS HAVE A DESIGNATED DRIVER**

1. Operators of golf carts **must be 16 years of age and possess a valid state-issued driver license.** Driver is responsible for maintaining one passenger per seat rule – no overloading of golf carts. No Horseplay Riding.
2. **PROHIBITS** golf carts from being on ANY public roadways, right-of-way, ditches or the crossing thereof at ANY time. Violators will be cited, fined and be subject to Jail.
3. **PROHIBITS** the Operation of a Vehicle under the Influence of alcohol or drugs – this includes bicycles and golf carts. Open containers/alcoholic beverages are not permitted in or on vehicles per State Law.
4. All golf carts must be equipped with headlights.
5. Golf carts may not be operated during designated 'quiet times' Quiet Time is from 10:30pm -6:30am. Golf carts/atv's must obey quiet time rules. No loud music, excessive partying while being operated.
6. Curfew Time is from (2:00am-6:30am). NO Golf carts/atv's will be operated during curfew time as announced by Lucas Oil Speedway Officials. Any cart/atv moving during curfew times is a violation of the rule and may result in loss of privilege and/or confiscation of the cart/atv till end of event which it will be impounded by Lucas Oil Security and or Hickory County Sheriff's Department.
7. **DO NOT** exceed the maximum passenger or weight capacity of your golf cart;
8. **ALWAYS** use extreme caution in highly congested areas, including but not limited to Pits, Campground, display areas, concessions areas, souvenir areas, crosswalks, entrances to infield, etc.;
9. **Maximum Speed Limit is 7 mph.** Excessive speeds will not be tolerated. Operators must yield to pedestrians at all times.
10. **Please watch for children, and other pedestrians and observe the Signs, Exits and Entrances.**
11. **NO DRIVING ON THE RACETRACK, OFF-ROAD TRACK OR ANY OTHER LUCAS OIL SPEEDWAY PROPERTY NOT SPECIFICALLY DESIGNATED FOR GOLF CART/ATV ACCESS! VIOLATORS WILL HAVE PRIVILEGES REMOVED AND VEHICLE IMPOUNDED.**
12. **ALWAYS** report any accidents or incidents golf cart is involved into the Hickory County Sheriff Office, Security and Speedway Officials at the time of occurrence. **CALL 9-1-1 IN CASE OF EMERGENCY.**

The Golf Cart Permit remains the property of Lucas Oil Speedway and is a privilege that can be revoked without cause. Guests shall apply for the Golf Cart Permit by completing the proper paperwork and submitting proof of insurance, at which time you will be considered for approval. Please read the following requirements for consideration of a Golf Cart Permit

**ELIGIBILITY:** An advanced ticket or camping order, business contract or approved entry application must be on file with Lucas Oil Speedway to be issued a Golf Cart Permit. The insured listed on the proof of insurance for the golf cart should match that of the Individual and/or Company name on the application. Only golf carts will be permitted on Lucas Oil Speedway property and all golf carts will require a Golf Cart Permit. Lucas Oil Speedway requires the make, model and serial number for the equipment to be permitted.

**INSURANCE:** You must have proof of insurance for your golf cart. Insurance is readily available through the same companies who provide your automobile and homeowner's coverage. In fact, you may already have it on your existing policy - check with your agent - comprehensive coverage is available for individually owned and operated carts, including: commercial general liability; collision damage liability; bodily injury and property damage liability; and accessory coverage. Golf carts owned and/or operated by businesses have access to commercial general liability; worker's compensation and employer's liability.

Please submit your completed application, proof of insurance and photo I.D. at the same time and in the same manner.

**COST:** Golf Cart/UTV Permit Pricing: Annual (Includes all specials) **\$75** per golf cart/utv. This fee is non-negotiable and payable to Lucas Oil Speedway upon approval of the application. Credit Card information and signature required for charge authorization. Golf Cart Permits are not issued until payment is made in full.

**ALL** Golf Cart Permits must be affixed as directed on the right side of the cowl or windshield (steering column is NOT permitted). All credentials are tamper evident and cannot be transferred.



## **GOLF CART/ATV/UTV PERMIT APPLICATION**

### **LUCAS OIL SPEEDWAY GOLF CART PERMIT TERMS AND CONDITIONS**

1. **AGREEMENT:** This document properly executed by Individual and/or Company, shall upon written acceptance by LUCAS OIL SPEEDWAY constitute a valid and binding agreement and unless terminated earlier in accordance with its provisions herein, shall continue through midnight on the day immediately following the completion of the last Event Weekend as identified in the published Event Schedule. Individual and/or Company represents and warrants that all the information provided by Individual and/or Company is and shall remain true and correct. Individual and/or Company warrants that it and its agents, employees, guests and authorized users shall comply with the terms of this Agreement.

2. **FEES:** In consideration of the rights granted by LUCAS OIL SPEEDWAY to Individual and/or Company hereunder, Individual and/or Company agrees to pay LUCAS OIL SPEEDWAY the Golf Cart Permit fee in the amount as indicated on the Request Form, if applicable, per Golf Cart Permit requested. All monetary obligations owed to LUCAS OIL SPEEDWAY hereunder are due and payable in full at the time of confirmation of Golf Cart Permit availability for the Term. No golf cart will be registered, and no Golf Cart Permit will be issued until such payment is received. In the event a replacement golf cart permit is needed, Individual and/or Company must surrender previously issued Golf Cart Permit, and will only, at that time, be granted a replacement. In the event a Golf Cart Permit is lost and or stolen, Individual and/or Company hereunder, is obligated to pay the FULL replacement costs of Golf Cart Permit to LUCAS OIL SPEEDWAY and will not be granted a replacement until payment has been received, unless otherwise agreed upon in writing by both parties. **ALL GOLF CART PERMIT FEES ARE NON-REFUNDABLE.**

3. **USE:** (a) **Golf Cart Permit:** Golf Cart Permits ("Permit") are non-transferable and must be permanently affixed to the front right side cowl or windshield. Individual and/or Company must report to the LUCAS OIL SPEEDWAY Golf Cart Registration (the "Compound") during the first day of the first Event Weekend for which a Permit is issued, and the required Permit will be applied by an authorized LUCAS OIL SPEEDWAY employee or representative. Failure to display Permit may result in impoundment and subject to additional fees. Permits do not grant Equipment access to grandstand, concourse, infield, pit area or other secured areas of Speedway property. At any and all times during the Term, LUCAS OIL SPEEDWAY or Speedway retains the right to revoke Equipment or Permit privileges should they be abused or used improperly. Permits become null and void on the last day of the preceding month in which Individual and/or Company's insurance policy expires. Individual and/or Company must submit a new certificate of insurance to receive a replacement Permit.

(b) **Rules and Regulations:** Individual and/or Company shall observe and abide by the Golf Cart Permit Rules and Regulations attached to this document as Exhibit A and incorporated herein by reference, and with any additional rules or regulations that hereafter may be adopted and announced by LUCAS OIL SPEEDWAY (collectively, the "Rules and Regulations"). Individual and/or Company acknowledges and understands that each Speedway may have different or additional rules and regulations, and policies and procedures regarding Equipment use and that it is Individual and/or Company's responsibility to ensure that it has obtained and understands all applicable rules and regulations, and policies and procedures. Individual and/or Company shall ensure that its employees, agents and other authorized users of Permits issued under this Agreement shall be given a copy of all referenced Rules and Regulations.

(c) **Accidents; Damage or Loss:** Should Individual and/or Company or Individual and/or Company's Equipment cause or become involved in an accident of any kind, regardless of the seriousness, the operator of Individual and/or Company's Equipment must stop and contact the Hickory County Sheriff Deputies, Speedway Security and LUCAS OIL SPEEDWAY representatives, and in such event the operator of the Individual and/or Company's Equipment must remain at the accident scene until Deputies and/or LUCAS OIL SPEEDWAY personnel advise they may leave. LUCAS OIL SPEEDWAY shall not be responsible for damage or loss to Individual and/or Company's Equipment or personal property left in or around the Equipment.

4. **INSURANCE:** Individual and/or Company shall maintain, at their own cost and expense throughout the duration of the Agreement a policy of insurance reasonably acceptable to the Hickory County Sheriff Patrol and LUCAS OIL SPEEDWAY.

**The information listed within provides guidance regarding the valid usage of golf cart or atv type vehicles hereinafter referred to as golf carts/atv's at Lucas Oil Speedway. Operators of golf carts/atv's understand that they do so at their own risk, and will relieve and hold harmless Lucas Oil Speedway for any and all debts that might occur from theft, accidents, and/or injuries involving the use of the golf cart/atv.
